

****END USER LICENSE AGREEMENT****

****TARGUS SOFTWARE, WEB PAGES, AND THIRD-PARTY SOFTWARE****

This End User License Agreement ("Agreement") is a legal agreement between you (either an individual or an entity) and Targus International LLC ("Targus") for the use of Targus software, web pages, and third-party software available on Targus.com, its support pages, and all international worldwide web pages for Targus (collectively referred to as the "Software"). By accessing, installing, or using the Software, you agree to be bound by the terms of this Agreement. If you do not agree with these terms and conditions, promptly uninstall the Software.

****1. GRANT OF LICENSE****

****3. RESTRICTIONS****

You shall not:

- Modify, translate, reverse engineer, decompile, disassemble, or create derivative works based on the Software, except to the extent expressly permitted by applicable law.
- Remove any proprietary notices, labels, or marks from the Software.
- Distribute, lease, rent, lend, transfer, or sublicense the Software to any third party.
- Use the Software in any manner that could damage, disable, overburden, or impair Targus's servers or networks.

****4. THIRD-PARTY SOFTWARE****

The Software may include third-party software components that are subject to separate license terms. Your use of such components is subject to those terms. Targus is not responsible for any third-party software and makes no representations or warranties regarding such software.

****5. UPDATES AND SUPPORT****

Targus may, from time to time, provide updates or modifications to the Software at its discretion. Targus is not obligated to provide support, maintenance, or updates for the Software.

****6. TERMINATION****

This Agreement is effective until terminated. Targus may terminate this Agreement at any time without notice if you fail to comply with any term of this Agreement. Upon termination, you must cease all use of the Software and destroy all copies in your possession or control. Targus will be entitled to all remedies in accordance with applicable law.

****7. DISCLAIMER OF WARRANTIES****

THE SOFTWARE IS PROVIDED "AS IS" WITHOUT WARRANTY OF ANY KIND. TARGUS DISCLAIMS ALL WARRANTIES, WHETHER EXPRESS, IMPLIED, OR STATUTORY, INCLUDING, BUT NOT LIMITED TO, WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, TITLE, AND NON-INFRINGEMENT. TARGUS DOES NOT WARRANT THAT THE SOFTWARE WILL MEET YOUR REQUIREMENTS OR THAT THE OPERATION OF THE SOFTWARE WILL BE UNINTERRUPTED OR ERROR-FREE.

****8. LIMITATION OF LIABILITY****

IN NO EVENT SHALL TARGUS BE LIABLE FOR ANY INDIRECT, INCIDENTAL, SPECIAL, CONSEQUENTIAL, OR PUNITIVE DAMAGES, OR ANY LOSS OF PROFITS OR REVENUES, WHETHER INCURRED DIRECTLY OR INDIRECTLY, OR ANY LOSS OF DATA, USE, GOODWILL, OR OTHER INTANGIBLE LOSSES, ARISING OUT OF YOUR ACCESS TO OR USE OF OR INABILITY TO ACCESS OR USE THE SOFTWARE, EVEN IF TARGUS HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES. ****10. INDEMNIFICATION****

You agree to indemnify, defend, and hold harmless Targus and its officers, directors, employees, and agents from and against any claims, liabilities, damages, losses, and expenses, including reasonable attorneys' fees, arising out of or in any way connected with your use of the Software or your violation of this Agreement.

****11. GOVERNING LAW****

This Agreement shall be governed by and construed in accordance with the laws of the state of California, without regard to its conflict of law principles. Any legal actions or proceedings arising out of this Agreement shall be brought exclusively in the federal courts of the United States or the courts of the State of California in each case located in Orange County, California. You waive any and all objections to the exercise of jurisdiction over you by such courts and to venue in such courts.

****12. MISCELLANEOUS****

- If any provision of this Agreement is held to be invalid or unenforceable, the remaining provisions shall continue in full force and effect.
- This Agreement constitutes the entire agreement between you and Targus regarding the Software and supersedes all prior or contemporaneous understandings and agreements, whether written or oral, regarding the Software.
- No waiver of any term of this Agreement shall be deemed a further or continuing waiver of such term or any other term, and Targus's failure to assert any right or provision under this Agreement shall not constitute a waiver of such right or provision.
